Fantozzi pointed out that money needed to be moved to cover this and suggested it come from election equipment as we had just received \$2500 back from last year's payment. Motion made by Day/Snyder. Roll call vote – Rivard-yes; Snyder-yes; Fantozzi-yes; Day-yes; Dubayyes. Motion carried.

Motion carried.
