- Received a quote to replace Tanker 21 for \$675,000. Board would like to see the cost to rebuild the existing truck for a comparison.

- **Northern Bay Ambulance**

- Budget will be revisited for the next 3 months
- Ambulance was purchased, they are going to be replacing the labels and should be in service soon. Currently they are down to one ambulance due to 2 being out of service right now.

- **New Business:**

- NBA - \$28k was paid from township to pay for new ambulance and increase in cost for service through 2022 winter taxes.
- Yard Maintenance - 2 bids submitted. Ryder Property Management submitted a bid for \$22,600. Turk Law Care submitted a bid for 4 \$15,225. Contract was awarded to Turk Law Care for 2022. Motion made by Paul and seconded by Sean. Approved by all.
 - Zero turn and finishing mower will be auctioned off later this year.
- Erickson Rd bridge will be replaced in 2023 for no cost to the residence.
- Roads - Rogers rd. ditches will be sprayed to prevent vegetation growth. A 3rd coat of chip and seal will be placed on Newburg. 11 Mile Rd. will have 1,000 tons of gravel added to a 2 mile stretch. Rogers Rd. will have 500 tons of gravel added.

- **Misc. Board:**

- Blight - We need to create a committee to start planning for blight complaints. Looking for volunteers. Motion made by Karen and seconded by Sean. Approved by all.
- Dumpsters will be delivered for spring cleanup on April 15th 2022.
